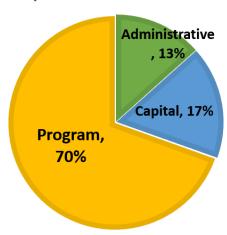

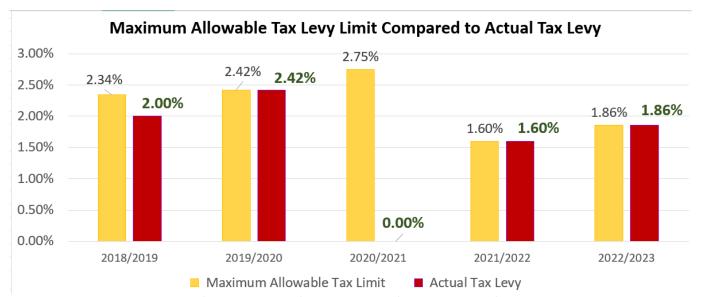

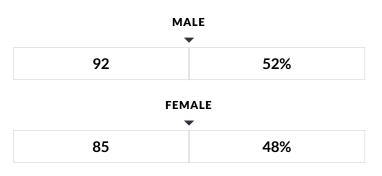

JEFFERSON CSD ENROLLMENT (2020 - 21)

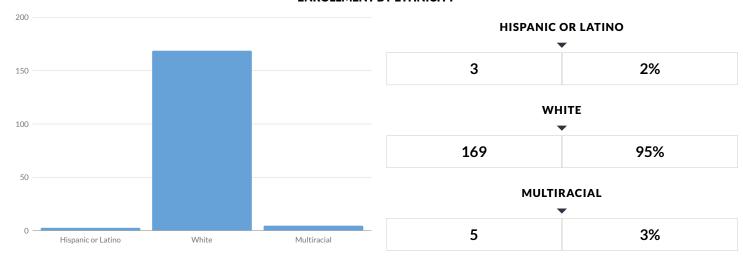

ENROLLMENT BY GENDER

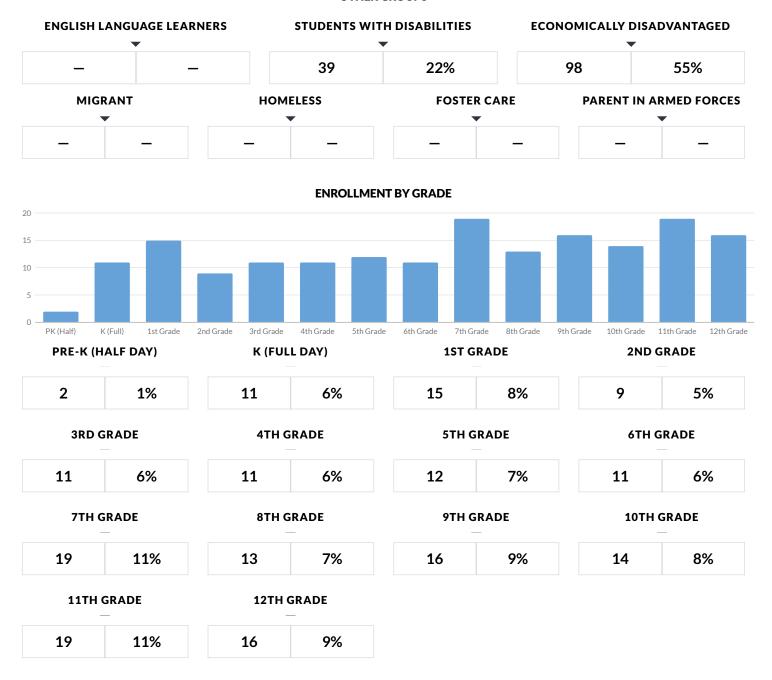




ENROLLMENT BY ETHNICITY
